Historic Meeting

On January 6, 2002, representatives of the Ala. Quail Hunters Assoc., Quail Unlimited, and the Ala. Wildlife Federation met with key Alabama Senators and Representatives to discuss the development of legislation to support Bobwhite Quail in our state. The locale for the meeting was the Pa-Ko Plantation in Midway and the owner was an outstanding host. Mr. Paul provided a wonderful field experience that approached a "hands on" lesson in the economic potential, which "Gentleman Bob" means to our great state. Citing his business in particular, Mr. Paul shared with the attendees, the multiple layers of economic impact that his business provided the community. The employment of staff (both full and part-time), purchase of farm seed and supplies, equipment purchases and large scale maintenance, procurement of birds from local breeders, and a substantial cost in grocery and dry goods were but a few of the economic benefits which the community enjoyed as a result of the Pa-Ko operation. Another fact that constantly came up was the lost revenue opportunity Alabama landowner's experience. Landowners from certain other states enjoy legislative line-item budgetary consideration because lawmakers have realized the correlation between this wonderful bird and serious economic revenue.

This gathering was designed to enlighten engage the enthusiastic involvement of all the attendees. J Paul set the stage well and the speakers had a willing audience that wanted badly to see what was to come and how could they help. During the presentation each person in attendance could see that our law-making guest truly had the best interest of our group at heart. Each of the gentlemen realized the importance of the issue at hand and worked hard to provide us with needed guidance. This was especially true of Senator Lowell Barron. Senator Barron provided excellent leadership throughout our meeting and was instrumental in not only outlining the legislative process, but also in identifying the needs which must be addressed as the "Initiative" moves from the drawing board to an actual bill. Much hard work has occurred but each of us came to know that achievement is not realized in a sprint but rather in a marathon. This meeting may be considered as our critical first step in a most worthwhile journey to preserve the beloved Bobwhite Quail and its habitat.

Spring Field Trial

Our 8th Annual Alabama Quail Hunters Field Trial is set for March 23. It will be at the same site we had it last year, Frost Farms. This is an absolutely perfect location for both spectators and participants. This will be a great place to bring friends and family to view great dogs competing.

In an effort to accommodate more dogs, we are going back to a format similar to Shoot to Retrieve with 2 dog braces and running on 2 fields at the same time. There will be 3 classes. Puppies are up to 12 months, Derby will be up to 24 months and over age 2 will be All Age (Gun dog). This Trial will be competitor friendly with the judges working with you and answering any questions about the simple rules. Rarely to almost never is a competitor or dog disqualified and most of the subjectivity has been removed from the scoring system.

Presidents Corner

Since my last column in October, the priority of small game habitat in Alabama has moved up rather dramatically. After reading Mike Barlow's report, you have got to be encouraged. A lot of people worked hard to put this meeting together. I want to thank Frank Harris and Mike for attending and doing a fine job of representing our group.

Shortly after that meeting, Senator Barron, on January 10, introduced a bill, which was co-sponsored by 14 fellow senators. This bill was subsequently amended with major changes to further improve wild quail habitat.

When it hopefully becomes law, it would establish the Alabama Quail Trail and Bobwhite Restoration Initiative (AQT-BRI) as a public non-profit corporation to study and implement plans to reverse declining Quail Habitat and promote and market hunting preserves with an emphasis on bringing needed recreational dollars to rural Alabama.

So as you can see, good things are happening. If you would like the details of the latest version of this bill (there have been 3 so far), come to our next meeting when we can bring you up to date.

Hoover High Demo

We will again be putting on a demonstration for the Hoover outdoors club. We had a lot of fun the last two years introducing the students to our sport and showing off our dogs. This year on Feb 20, at 1pm, we will be showing as many different pointing dog breeds as we can round up.

If you are not participating or spectating at field trial, you are missing a real treat. They are a great place to bring friends and family to view great dogs competing. Most of the newer trials are competitor friendly with the judges working with you and explaining rules and working with you. Rarely to almost never is a competitor or dog disqualified. Most of the subjectivity has been removed from the scoring systems and you have several options as to which form best suits you and your pup or dogs. Whichever format you like, you will not win ever time no matter how good your dog is. Most likely, you will also have to compete several times before you place or win. But you will certainly like the competition. My dog Jake is pretty smart but he cannot tell whether he has won or lost.
