## **Field Trialing Primer**

Many if not most birddog enthusiast are actively participating in some form of Field Trial with their dogs. This short article is for those folks that have not entered a dog or entered one a couple of times and decided trialing is not for them.

To start with, there are several forms of trialing. The big divider is horseback or foot. If you like to ride horses, get a big running dog and be prepared to spend a lot of time and money with training up North in the summer and trialing all over in the Fall and Winter.

There is the National Bird Hunters which is best described as horseback hunting without the horse. The dogs run big but the handler is on foot. The gallery rides in a tractor pulled wagon.

NASTRA (Nat. Shoot To Retrieve Assoc.) has 2 dogs competing in a field of about 20 ac. with 5 released birds.

Dogs are scored on points, retrieves, backs and field coverage. Each dog competes in an A and B field and combined score wins. The hunter must be able to bring down the bird so his dog can make the retrieve.

United Field Trialers Associations is the newest group and the one that I have recently joined. Scoring is based on the time it takes to bag three released birds in a field. Each dog runs in 2 fields and the best combined score wins. There are major deductions for missed shots and partial retrieves.

There are two reasons why I am competing with UFTA. The first reason is my 10 month old pup J. J. who handles exceptionally well but has several puppy flaws on points and retrieves. Next year, I plan to also enter him in NASTRA and NBA.

The 2nd reason is that UFTA will hold their Nationals at Doublehead Resort at Joe Wheeler State Park. This event

is coming mainly because of the determined efforts of one of our members, Laylon Cox.

## **HEY FOLKS**

Congratulations Alabama Quail Hunters!!! You have been incorporated TEN YEARS! Our Charter Members who signed the Articles of Incorporation were Jim Bradford, Terry Ballew, Price McGiffert, Harold Spradley, Aaron Parker, David Crawley, John Walker and Frank Harris. Jim Bradford served as the first president. While I was not involved with the conception of the idea for a local quail club, I was involved by the time of our club's incorporation.

The genesis story of AQH as it was told to me is as follows. While a group of men were playing golf, one openly stated that he enjoyed quail hunting much more than golf, but there were declining places to hunt and decreasing quail numbers. This was the spark for establishing AQH. Initially, the focus of the club was to locate a field for

dog training. AQH now has 365 acres leased in Cullman County for dog training and hunting. Other activities include our monthly meetings, some with outstanding speakers about Mr. Bob White and related subjects including improving quail habitat or your dog's training and performance. Some speakers have been discouraging to the small landowner, reporting that you needed 10,000 acres to maintain a wild bird population. Today, there are some success stories of wild quail coveys established on tracts of about 400 acres.

Reflecting back over our history, it was very interesting in the early days to listen to our members speculate on the problems quail face, like the coyote. Our wildlife biologist speakers would point out that nest raiding predators like rat snakes,

raccoons and opossums and avian predators like the Cooper's Hawks were of a much greater threat. We are now much better educated on the limiting factors of a thriving quail population. Wild quail are possible if one can control the plant mix in their habitat and the predation on sufficient acreage.

Some of our other key successes over our history are that AQH now has two members active on the Quail Council, we publish a quarterly newsletter, and we host a fall and a spring field trial every year. Most of all, we have fun with each other and we all enjoy working to benefit Mr. Bob White.

Join me in celebrating this milestone, the Tenth Anniversary of your club.
